CHAPTER 1 – GENERAL GOVERNANCE AND ESTABLISHMENT

Final Results. The results of a **Competition** that have become final in accordance with **Ch.3 App.6 Art.1.4.**

Provisional Results. The results of a **Competition** before they become **Final Results** in accordance with **Ch.3 App.6 Art.1.4.**

CHAPTER 3 – ORGANISERS

Appendix 6 – Publication of Results

- 1.3 ~~Where published,~~ the date and time of issue of all **Provisional Results** and **Final Results** should be stated on them and they should be signed by the **Clerk of the Course** or their **Deputy**.
- 1.4 ~~These results~~ Subject to the authorities vested in the **ASN** and the independent **National Court** under the **NCR**, **Provisional Results** become **Final Results** when:
- any **Protest** or **Appeal** time has expired; and
 - all official enquiries by the **Clerk of the Course** and/or the **Stewards of the Event** (when acting as the first **Judicial Body**) and/or the **Race Director** have been settled; and
 - at the final conclusion of all technical matters and all outstanding **Protests** or **Appeals** have been settled unless otherwise directed by the **ASN**.

Appendix 1 – Competitors and Entrants Responsibilities

- 4.5 The results of a **Competition** will be 'Provisional' **Provisional Results** until they become **Final Results** in accordance with **Ch.3 App.6 Art.1.4**. ~~all Vehicles subject to Post-Event Scrutiny have been examined and a report submitted to the Clerk of the Course, all official enquiries by the Clerk of the Course and / or Race Director completed and every Competitor has had an opportunity to Protest and / or Appeal in accordance with the Regulations and such Protest or Appeal has been duly heard.~~

Appendix 9 – End of Race Results

- 1.2 All **Results** at the **Event** including **Provisional Results** provisional and / or **Final** final **Results** shall be calculated in accordance with the **Official Documents** (see **Ch.3 App.10**) following the application of any Penalties to **Competitors** (see **App.10 to this Chapter** and **Ch.2**).
- 1.3 The results of an **Event** will be **Provisional Results** until they become **Final Results** in accordance with **Ch.3 App.6 Art.1.4**. ~~Except for the several authorities vested in the **ASN** and the independent **National Court** under the **NCR** the **Results** of an **Event** shall remain **Provisional Results** until the final conclusion of any **Appeals** (see **Ch.2**) affecting the **Results** of the **Event**.~~
- 1.4 **Results** that remain provisional under **Art.1.3 above** shall only be declared and published by the **Organisers** as **Final Results** following the conclusion of all **Judicial** procedures including but not exclusively any **Appeals** arising from the **Event** (including **Appeals** against the **Provisional Results**).
- 1.5 Specific regulations regarding **Organisers** and the publication of **Results** are provided at **Ch.3 App.6**.

CHAPTER 16 – AUTOCROSS AND RALLYCROSS AND OFF-ROAD RACING

Appendix 6 – Organisers Regulations

- 10.2 All **Results** at the **Event** including **Provisional Results** provisional and / or **Final** final **Results** shall be calculated in accordance with the **Official Documents** (see **Ch.3 App.10**) following the application of any Penalties to **Competitors** (see **Ch.2**).
- 10.3 The results of an **Event** will be **Provisional Results** until they become **Final Results** in accordance with **Ch.3 App.6 Art.1.4**. ~~Except for the several authorities vested in the **ASN** and the independent **National Court** under the **NCR** the **Results** of an **Event** shall remain **Provisional Results** until the final conclusion of any **Appeals** (see **Chapter 2**) affecting the **Results** of the **Event**.~~
- 10.4 **Results** that remain provisional under **Art.10.3 above** ~~Art.8.3 above~~ shall only be declared and published by the **Organisers** as **Final Results** following the conclusion of all **Judicial** procedures including but not exclusively any **Appeals** arising from the **Event** (including **Appeals** against the **Provisional Results**).
- 10.5 Specific regulations regarding **Organisers** and the publication of **Results** are provided at **Ch.3 App.6**.

Date of Implementation: 1 January 2027

Reason: To clarify, remove unnecessary duplication, and ensure alignment in respect of the requirements for '**Provisional Results**' to become '**Final Results**'. Definitions are confirmed in NCR Ch.1 App.1. Conditions are clarified within Ch.3 App.6. Cross-references and duplication are updated and removed within the specific discipline chapters for Race and Rallycross (respectively).
